

EJN Mentoring scheme for Programmers

A new generation of curators learning from more experienced EJN members

The mentoring scheme in brief

- EJN will support 2 mentorings per edition, for two editions during the current
 Creative Europe project (2025-2028). The 1st edition will take place between the
 1st of June 2025 and 30th of September 2026; the 2nd edition will be from
 October 2026 to September 2028. We are now launching the call for the first edition
 of the scheme (taking place between 2025-2026).
- Any representative of a EJN member (active* EJN members and honorary EJN members) with a solid background experience in programming can can candidate to be a mentor under this mentoring scheme (more details below).
- Mentees must be associated, and apply through, an active* member organisation (full/part time staff, collaborators, trainees, volunteers);
- Mentees must be UNDER 35 YEARS OLD at the point of the commencement of their mentoring programme, and priority will be given to female and non-binary applicants, and to other under-represented groups
- The selected mentee and mentor will be "matched" by the EJN mentorship committee after the deadline of individual applications (more details below).
- An EJN mentorship scheme is composed of:
 - ONE in-person field visit by the mentee of maximum 5 consecutive days at the premises of the mentor (festival, venue, etc), to be scheduled in agreement with the mentor;
 - At least 3 online mentoring sessions over the course of at least 10 months;
 - ONE final in-person meeting during the next European Jazz Conference (2026 for the first scheme; 2028 for the second scheme).
- The mentoring scheme is intended to support developing new skills and competences for working in the creative music sector as a programme of a venue or festival.
- The mentors and mentees **CANNOT** be from the same country, in line with EJN's mission to foster international collaboration and exchanges.
- The specific objectives and the calendar of the mentoring activities must be outlined
 in the educational programme that must be developed together by the mentee
 and mentor after they have been "matched" by the EJN mentorship committee
 (more details below).



- Each mentee will be requested to send a report to EJN at the end of the scheme, based on a fixed template, indicating the work done/lessons learnt/personal evaluation of the experience. Parts of the report will be used on the EJN website and in EJN communications.
- Each mentor will also be required to complete a survey to evaluate the experience and plan the next editions.
- Each mentee is also requested to document his/her mentorship experience, especially in-person events, through photos and videos, and to publish them on social media, in order to give visibility to the scheme and the support from EJN and Creative Europe, tagging @europejazznet in the relevant posts (instagram, facebook, etc...).
- Mentors and mentees must strictly adhere to the <u>EJN Code of Conduct</u>, that is in place for the whole duration of the programme, as for all EJN activities.

How a mentor can apply

- Any representatives of active* EJN member organisations (and EJN honorary members) with a solid background experience in programming can be a candidate for the EJN mentoring scheme, by filling an online form.
- A call for mentors will be launched in the middle of February 2025 with a deadline on Tuesday, 15 April 2025.

- The candidate must provide an overview of their areas of expertise and skills, together with some background information about the history of their work experience and contact information.
- All the information about the proposed mentors will be collected and evaluated by the EJN mentorship committee, and two mentors will be selected for the first edition. These two mentors will be then "matched" with two mentees by the EJN committee, according to the needs and expectations of both parties.
- The selected mentors must commit to the educational programme that will be prepared together with the mentees (see below) after the selection, including the attendance at the European Jazz Conference 2026 for the first edition.
- Mentors who take part in the first mentoring edition may also be able to participate in the second mentoring edition.



How a mentee can apply

- A specific call for mentees will be published in the middle of February 2025, which will require applicants to provide some basic personal information, information about the member organisation, the applicant's previous experience, motivation and expectations, and the type of mentor she/he/they are looking for.
- The application deadline for the first edition for mentees will be on Tuesday, 15 April 2025.

- Through the mentoring programme, the mentees are expected to acquire concrete skills and competences to develop artistic programmes for a venue or a festival, in areas such as:
 - Booking identifying & securing artists, negotiating contracts;
 - Concert programming audience development, curating a diverse & engaging lineup;
 - Commissioning of new projects: initiating the creation of original works, collaborating with artists,
 - Diversity in programming: promoting inclusivity by engaging artists from different backgrounds, genres & cultures.
- Selection will be made by the EJN mentorship committee on the basis of the
 information provided, and short online interviews may be conducted if
 necessary. The EJN mentorship committee will then "match" the two selected
 mentees with two mentors. After this, it will be the responsibility of the mentee and
 the mentor together to develop the educational programme, including the schedule
 and content of the mentoring sessions. These must be submitted to EJN at the
 beginning of the mentoring period.
- We expect a full commitment from both the mentors and mentees to the programme.
 If, after their initial meetings, the programme does not meet the expectations of the two parties, EJN will look to resolve the issue to the satisfaction of both as best as possible, on a case-by-case basis.
- Mentees and sending EJN organisations that are selected for the first edition will not be able to apply to the second edition.

EJN will cover for the mentor

- One fee (lump sum) for her/his/their services for the mentoring scheme of €2.000,00 (gross, tax incl.)
- No additional travel or accommodation costs will be provided for the mandatory attendance at the European Jazz Conference 2026 and/or 2028, which are already provided under the normal conditions of membership.

EJN will cover for the mentee

Travel and accommodation costs for **ONE in-person field visit** to the designated area of the mentor for a maximum of **5 consecutive days**, as follows:

- TRAVEL: A contribution to travel costs (flight/train/bus/ferry/metro/tram), including transportation back and forth to the mentor's area and local transportation during the mentoring visit period, on the basis of the most convenient fares, for a maximum of €300 for the whole mentoring visit, based on actual expenses incurred. PLEASE NOTE: in order to incentivise the use of sustainable means of transportation and to cover resulting additional costs, the maximum reimbursement for transportation to/from the mentor location ENTIRELY by train can be up to max 350€, instead of 300€;
- ACCOMMODATION: A contribution to accommodation costs (hotel/airbnb/etc...) for each participant for the duration of the exchange up to max. 100€ per night per max.
 5 consecutive days. If accommodation expenses exceed 100€ per night, the difference must be covered either by the participant or by the sending/host organisation;
- SUBSISTENCE: A contribution/daily allowance of up to max. €50 per day to cover food expenses of the mentee. The allowance will be based on actual expenses and will be reimbursed directly to mentees upon submission of original receipts and a request for reimbursement.

In addition, the mentee will be granted the participation in the European Jazz Conference 2026 in Cologne, Germany (for the first edition), with a contribution to travel expenses (up to €300), 3 nights accommodation, meals as part of the Conference programme and a free registration to the conference.
